MODIFIED PENALTY NOTICES

PUBLICATION PURSUANT TO SECTION 99E(3) ENVIRONMENTAL PROTECTION ACT 1986

1. Polaris Metals Pty Ltd caused or allowed a liquid waste to be discharged in a place other than water to which the public has access, which is an offence under section 49A(3) of the Environmental Protection Act 1986.
Penalty paid: \$12,500
2. Polaris Metals Pty Ltd altered a method of operation of a trade carried on at their premises, causing an emission into the environment, which is an offence under section 53(1)(a) of the Environmental Protection Act 1986.
Penalty paid: \$10,000
