MODIFIED PENALTY NOTICES

PUBLICATION PURSUANT TO SECTION 99E(3) *ENVIRONMENTAL PROTECTION ACT 1986*

1. Avoca Mining Pty Ltd caused hypersaline water to be released into the environment causing damage to native vegetation at Higginsville, which is an offence under section 50B(2) of the *Environmental Protection Act 1986*.  
PENALTY PAID: - \$25,000
2. BHP Billiton Nickel West Pty Ltd failed to maintain a 300mm freeboard at its return water dam in Kambalda, breaching a condition of the DER licence which is an offence under section 58(1) of the *Environmental Protection Act 1986*.  
PENALTY PAID: - \$12,500
