Amendment Notice

This amendment is made pursuant to section 59 of the *Environmental Protection Act 1986* (EP Act) to amend the Licence L6161/1988/13 issued under the EP Act for a prescribed premises as set out below. This notice of amendment is given under section 59B(9) of the EP Act.

This notice is limited only to an amendment application received by Department of Water and Environmental Regulation (DWER) on 5 September 2018 in relation to Category 8 Prescribed Premises activities as described in Schedule 1 to the *Environmental Protection Regulations* 1987 (EP Regulations).

The following guidance statements have informed the decision made on this amendment:

Amendment description

Yoganup Extended Mineral Sands Mine (the Premises) is currently in care and maintenance undertaking rehabilitation works. The waste disposal pit ("90 ft. pit") remains active within the Premises receiving construction and demolition waste from decommissioning works and tailings from Category 8 activities from external operations held by Iluka Resources Limited (Licence Holder).

This amendment relates to extending the delineated boundary in place at the "90 ft. pit" as outlined in Schedule 1 Maps in the Existing Licence. This extension does not authorise an increase in waste limits or any changes to the waste types received at "90 ft. pit". The Licence Holder proposes that waste received at the "90 ft. pit" will remain in accordance with Condition 1.2.1 of the Existing Licence. The Licence Holder has not proposed any other changes to the Existing Licence Conditions.

This amendment does not alter or change any discharges or emissions associated with existing operations at the Premises, therefore, there is no change to the risk profile already assessed and does not require a reassessment of risk to sensitive receptors.

Decision

The Delegated Officer has determined that the extension to the delineated boundary at "90 ft. pit" at Yoganup Extended Mineral Sands Mine does not change the environmental risk associated with existing operations. The Delegated Officer has granted the amendment.

Schedule 1 of the licence has been amended to include the new waste disposal site map and coordinates. There are no further condition changes to the Existing Licence required from the amendment.

Licence Holder's comments

The Licence Holder was provided with the draft Amendment Notice on 8 August 2019. Comments received on 9 August 2019 from the Licence Holder requesting to waiver the consultation period, no further comments were provided.

Amendment

1. Schedule 1 of the Licence is amended by the replacement of the Map of the waste disposal site with figure shown below:

The location of the "Yoganup Extended Radioactive Waste Disposal Pit" as defined in Table 1.2.2 is shown below. The blue delineated line outlines the maximum extent of disposal permitted.
