Amendment Notice

This notice is issued under section 59 of the *Environmental Protection Act* 1986 (EP Act) to amend the licence issued under the EP Act for a prescribed premises. This notice is given under section 59B(9) of the EP Act.

Amendment Description

Cliffs Asia Pacific Iron Ltd (Cliffs) operates the Windarling Iron Ore Mine which is subject to conditions under both Part IV and Part V of the EP Act.

On 29 September 2016 the Environmental Protection Authority issued approval under section 45C of the EP Act for development of an additional mine pit, W10.

Licence L8667/2012/1 currently authorises dewatering from open pits W1, W3 and W7 to W2 pit. This notice authorises installation and operation of additional infrastructure to allow dewatering from the new W10 pit to W2 pit. The location of W10 pit is indicated in the existing map in Schedule 2 of Licence L8667/2012/1. The coordinates delineating the permitted surface footprints for all mine pits, including W10, are included in the Part IV approval.

The Delegated Officer has assessed that the proposed additional dewatering will not change the risk profile of emissions and discharges. Therefore the licence conditions have not been changed other than an amendment to Table 2.2.1 to authorise W10 pit as an additional dewatering source for discharge to W2.
