Interpretation

Amendment Notice

This amendment is made pursuant to section 59 of the *Environmental Protection Act 1986* (EP Act) to amend the Works Approval issued under the EP Act for a prescribed premises as set out below. This notice of amendment is given under section 59B(9) of the EP Act.

This notice is limited only to an amendment to the expiry date for the Works Approval. No changes to the aspects of the original Works Approval have been requested by the Works Approval Holder.

Amendment description

DWER received a Works Approval amendment application on 19 July 2018 requesting an extension to the expiry date of the Works Approval for a period of 3 years, from 30 August 2018 to 31 August 2021. No other changes are proposed.

Decision

The Delegated Officer notes that the extension of the expiry date is to enable the completion of works associated with the proposal. The applicant advises that a number of investigative, acquisition and design activities have been undertaken in relation to the project since April 2016. The Delegated Officer considers that the extension of the works approval expiry date will not impact on the risk profile of the premises and that a detailed risk assessment is not required.

The Delegated Officer has granted the Amendment Notice 1 with the requested extension to the expiry date.

Works Approval Holder's comments

The Works Approval Holder was provided with the draft Amendment Notice 1 on 8 August 2018. The Works Approval Holder advised on 10 August 2018 that they have no further comments on the proposed changes and waive the remaining consultation period.

Amendment

1. The licence duration has been extended from *Thursday 30 August 2018* to *Tuesday 31 August 2021*.
