# **Amendment description**

This amendment is made pursuant to section 59 of the *Environmental Protection Act 1986* (EP Act) to amend the existing licence issued in respect of the prescribed premises as set out below. This notice of amendment is hereby given under section 59B(9) of the EP Act.

This amendment is limited to extending the installation date of groundwater monitoring bores MW04 and MW05. No changes have been made to any other existing conditions or licence holder obligations.

In completing the assessment documented in this report, the department has considered and given due regard to its regulatory framework and relevant policy documents which are available at <u>www.dwer.wa.gov.au/regulatory-documents</u>.

#### Purpose and scope of assessment

Licence L6395/1993/16 is held by Harvey Industries Group Pty Ltd (licence holder) for the Harvey Beef Abattoir (premises) located at Seventh Street, Harvey within the Shire of Harvey.

The department granted an amendment to licence L6395/1993/16 on 17 April 2024 following a licence holder-initiated application to amend the licence. As part of this amendment, the installation of groundwater monitoring bores, MW04 and MW05, were required to be installed by 30 September 2024. These groundwater monitoring bores are proposed to be located downgradient (MW04) and upgradient (MW05) of additional wastewater irrigation areas approved through the amendment granted on 17 April 2024.

On 11 July 2024, the licence holder applied to extend the installation date of these two groundwater monitoring bores to 31 December 2024 due to winter rains inhibiting equipment access to the proposed installation area.

### Consultation

The licence holder was provided with the draft revised licence and amendment report on 10 September 2024. The licence holder waived the remaining comment period on 12 September 2024.

## Decision

The delegated officer has considered the licence holder's request to extend the installation date for groundwater monitoring bores MW04 and MW05 and has determined that the change is administrative and does not alter the existing risk assessment.

Based on the assessment outlined in this amendment report, the delegated officer has amended licence L6395/1993/16 to extend the installation date of monitoring bores MW04 and MW05.

Additionally, an administrative amendment has been made to update the licence holder's registered business address, as per their licence amendment application and the Australian Securities and Investments Commission (ASIC) summary.

These changes are summarised below.

The decision report for the existing licence will remain on the department's website for future reference and will act as a record of the department's decision making.
