## 1. Decision summary

The Delegated Officer has determined to transfer Works Approval W6834/2023/1 from Vango Mining Limited to Dampier (Plutonic) Pty Ltd. As activities, emissions and receptors remain unchanged, the transfer is deemed administrative in nature and does not require a further risk assessment.

The decision report for the Existing works approval will remain on the department's website for future reference and will act as a record of the department's decision making.

## 2. Scope of assessment

#### 2.1 Regulatory framework

In making this decision, the department has considered and given due regard to its Regulatory Framework and relevant policy documents which are available at <a href="https://dwer.wa.gov.au/regulatory-documents">https://dwer.wa.gov.au/regulatory-documents</a>.

### 2.2 Application summary

Works Approval W6834/2023/1 is held by Vango Mining Limited for the Marymia Gold Project – Trident Project (the Premises), located at Mining Tenements M52/217 and M52/218, MEEKATHARRA WA 6642.

The Premises is for Category 6 and the assessed production capacity under Schedule 1 of the *Environmental Protection Regulations 1987* (EP Regulations) which are defined in existing Works Approval W6834/2023/1.

On 30 July 2024, Dampier (Plutonic) Pty Ltd (the applicant) submitted an application to the department to transfer Works Approval W6834/2023/1 under section 59B of the *Environmental Protection Act 1986* (EP Act).

It should be noted that:

- The name of the current works approval holder (Vango Mining Limited) has been changed to Vango Mining Pty Ltd; and
- Vango Mining Pty Ltd and the proposed new proponent Dampier (Plutonic Pty Ltd) are both wholly-owned subsidiaries of Catalyst Metals Ltd and this is an application to transfer the proponent from one subsidiary to another.

The transfer application is limited to changing:

- The Works Approval Holder from Vango Mining Limited to Dampier (Plutonic) Pty Ltd;
- The Australian Company Number (ACN) from 108 737 711 to 131 670 963; and
- The registered company address from Aurora Place Building 1, Level 29, 88 Phillip Street, SYDNEY NSW 2000 to Level 1 30 Richardson Street West Perth WA 6005.

It should also be noted that this Works Approval W6834/2023/1is currently under appeal, Appeal No: 028/24.

#### 2.2.1 Correction of an administrative error

It has been noted that Condition 18(d) of the existing Works Approval W6834/2023/1 refers to Condition 0, however, this should be Condition 17. This has been corrected during this transfer.

#### 3. Consultation

The Works Approval Holder was provided with the draft Decision Report on 05 September 2024. On 09 September 2024 the Works Approval Holder waived the comment period.

#### 4. Decision

Dampier (Plutonic) Pty Ltd has provided to the department evidence that they are now the legal occupier of the premises. Documents provided include the Department of Energy, Mines, Industry Regulation and Safety (DEMIRS) Tenement Register and ASIC extract. The department is satisfied that they are now the legal occupiers of the premises.

The Delegated officer has determined to transfer Works Approval W6834/2023/1 to Dampier (Plutonic) Pty Ltd on the grounds it is a current legal entity with legal access to the premises.
